Saturday, October 1: 10:00 AM to 11:00 PM – Vehicles can unload from 10 AM until 11 AM - Festival starts at 1:00 PM –Can shut down by 9 or 10 PM, but cannot bring vehicles on Trimble Ave until after 11 pm.

Vendor automobiles will NOT be allowed on-site at any other time than specified above.

Vendors must be open for business and operational during the following times (unless inclement weather conditions):

Festival ends Saturday October 1 at 11:00 PM Vendors should be completely cleared out by Midnight.

## General Conditions or Requirements of Arts and Crafts

- This is a rain or shine event
- The Bona Fide Blues Festival/Memphis Blues Society offers no guarantee of sales
- There will be NO knives, guns, drug paraphernalia, or weapons of any type allowed, and no toys that look like or may be used as items listed above.
- Vendors are responsible for maintaining the working order of their equipment throughout the festival.
- Vendors shall provide adequate trash receptacles with trash bag.
- Premises should be left in the same condition as found. This includes picking up trash in and around vendor area.
- Transfer of booth space to another vendor is not allowed.
- All merchandise must be clearly marked.
- Booths must remain open during designated times.
- Vendors read and agree to the Indemnity Agreement once the application is signed and returned.
- It is the responsibility of the vendor to pay any applicable taxes
- Nothing can be sold with the Memphis Blues Society or Bona Fide Blues Festival names or logo on it.

## Termination of Vending Rights

Memphis Blues Society, through the Bona Fide Blues Festival Project Director and/or authorized representative- Vendor Chair, reserves the right to terminate the operation of the vendor at any time during the festival for any of the following reasons:

- Professional manner is not maintained by the Craft Vendor or his/her employee
- Craft Vendor and/or employee commits any act detrimental to the purpose of the festival
- Craft Vendor and/or employee fails to cooperate with event management staff
- Craft Vendor and/or employee sells any product not listed on the approved list
- Craft Vendor and/or employee sells food or beverages not otherwise approved on product list

## Acts of God

Vendors understand that this festival is an outdoor event vulnerable to weather. Vendors understand that fees are non-refundable due to acts of God, inclement weather, dangerous conditions, acts or threats of terrorism, natural disasters, or war.

## Indemnification Agreement

The vendor agrees to indemnify, defend, protect, and hold harmless MBS/BFBF and their respective officers, directors, agents, members, associates and employees against any loss, damage, fire, penalty, claim(s), or other liability arising from the vendors participation in the BFBF. This release, indemnification, holds harmless agreement shall be, and is construed, as broadly and inclusively as is permitted by relevant federal law. If any portion of this document is held invalid, the balance shall continue in full force and effect.
